# [Application Guidelines : General Course 2 years]

This is basic course for general study abroad.

This course is designed to improve their high proficiency in Japanese on a long-term basis : up to 2 years. It is especially recommended to learners who want to enroll in higher education : vocational school, university or graduate school, and to get a job in Japan.

## ■ Admission Requirements

- Have high school graduate or equivalent
- Completed 12 years or more of general school education up to secondary level
- Certified with N5 on Japanese Language Proficiency Test (JLPT), or have already learned Japanese for 200 hours or more in their home country
- Be serious responsible and highly motivated

# ■ Application Procedures and Timeline

September	Applicants submit Enrollment Application Documents to the school.
October	The school examine all the application documents. Applicants are called to attend an interview.
October- November	Successful applicants submit application documents to the school.
Mid November	The school submits the documents to the Immigration Bureau to start procedures for the issue of a Certificate of Eligibility for Resident Status.
21 <sup>th</sup> February	The results of the examination conducted by the Immigration Bureau.
Late February	Applicants submit Certificate of Health filled in by a doctor. Diagnosis of infectious diseases must be referred.
Early March	Applicants pay School fees; admission fee, tuition fee and so on.
	Certificate of Eligibility for Resident Status and Admission Permit are forward to the applicants.
	Applicants request Visa from Overseas Diplomatic Establishment.
Early April	New students enter Japan on the date designated by the school. Start school, attend an orientation meeting, and now start class!

#### <Before their Arrival in Japan>

- ①Cancelling after the Certificate of Eligibility is issued, but before visa application documents are submitted to the Immigration Bureau.
  - ▶ 100% of the full payment excluding admission fee submitting Admission Permit and Certificate of Eligibility to the school is required.

### ②Cancelling after Visa application documents is submitted to the Immigration Bureau but not issued.

▶ 100% of the full payment excluding admission fee. Submitting Admission Permit and official documents which prove the Immigration Bureau refused them Visa is required.

#### **③Canceling after a Visa is issued**

▶ 100% of the full payment excluding admission fee. Submitting Admission Permit, and a proof that a Visa is not used and invalid is required.

#### <After their Arrival in Japan>

④Cancelling after their enrollment into the school without any justifiable reason.

### **⑤**Cancelling before their enrollment into the school.
